#### Methodology and Overview

This presentation is based on a national survey conducted by Greenberg Quinlan Rosner Research for Democracy Corps and Women's Voices. Women Vote Action Fund.

1000 likely 2012 voters (1000 weighted) were interviewed from February 11-14, 2012.


Unless otherwise noted, margin of error= +/- 3.1 percentage points at 95% confidence.

### The Collapsing Republican Brand

- Republican brand is in deep trouble over half of voters give the Republican Party and Congress cool ratings
- Republican primary race and Congressional battles dragging down
  Romney and the rest of the Republican Party
- Romney, the presumed nominee, is tanking and in deep trouble


### Republican brand in trouble – they continue to fall


#### Over 50 percent give Republicans negative ratings


# Disapproval of Republicans in Congress up to 68 percent

## Romney approaches majority negative; Santorum not much better




#### Sharp rise in negative feelings toward Romney




## Democratic Resurgence – Better Take Notice

- Democrats winning back seniors and consolidating their progressive base – youth, unmarried women and minorities





# The result: Obama approval hits 50 percent—highest in a year


Do you approve or disapprove of the way Barack Obama is handling his job as president?







## Obama has stronger support than Romney and more winnable voters




### Romney tanking with suburban voters



#### Romney underperforms McCain among seniors




## And Democrats near 2008 levels in Congressional vote




#### Still room for growth among youth, Hispanics




## Obama has consolidated Rising American Electorate since January

## But there's a considerable gap between unmarried and married women




# Reigniting Culture War Unlikely to Revive Republican Chances





## Catholics agree with Obama's stance on contraception

As you may have heard, under the new health care reform law, all health insurance plans, starting in August, will begin covering the costs of contraception and birth control, without any co-pays. Churches, synagogues, mosques and places of worship were exempted, but Catholic hospitals and universities that employ people of different faiths, when they provide health insurance, those policies will need to cover the cost of contraception and birth control. 


